1. What is this product?

Term	The product does not have a fixed term, subject to exercise by you or termination by the product issuer

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. Following the issuance of the product, the stop loss level and the strike level will be adjusted for current market conditions and a financing rate. The financing rate is calculated and accrued daily based on the difference between two overnight floating rates minus a spread.
