1. What is this product?

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the **underlying**. The product has no fixed term. The product may terminate at any time as described below. <u>Leverage</u>: The product offers leveraged exposure to the performance of the **underlying**. The exercise or termination, as the case may be, will be effective after the period of time indicated in the product terms.

Unless a knock-out event has occurred, you will in both cases on the **settlement date** receive a cash amount equal to (1) (A) the **reference level** on the **valuation date** minus (B) the **strike level** on such date multiplied by (2) the **entitlement**, subject to a minimum of EUR 0.001.

Following the issuance of the product, the **knock-out level** and the **strike level** will be adjusted for current market conditions and a financing rate. The financing rate is calculated and accrued daily based on an overnight floating rate plus a spread. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.
