1. What is this product?

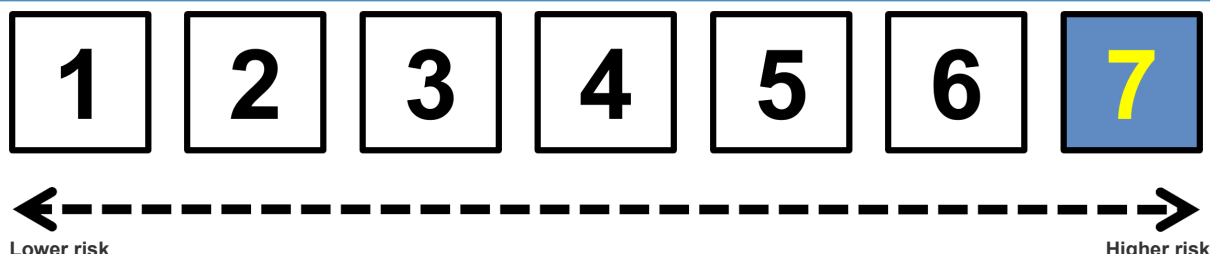

Recommended holding period: 1 day
