1. What is this product?

The financing rate is calculated and accrued daily based on the difference between two overnight floating rates minus a spread. 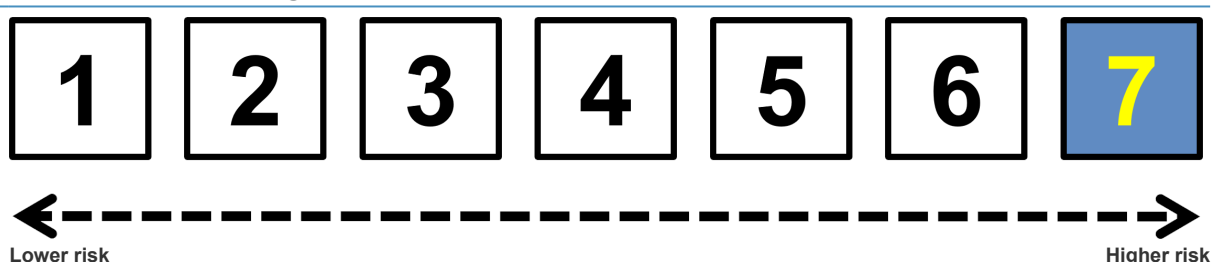

The product is intended to be offered to retail investors who fulfil all of the criteria below:

5. How long should I hold it and can I take money out early?
