1. What is this product?

Unless a knock-out event has occurred, you will in both cases on the settlement date receive a cash amount equal to (1) (A) the strike level on the valuation date minus (B) the reference level on such date multiplied by (2) the entitlement, and converted into EUR at the FX rate, subject to a minimum of EUR 0.001. Following the issuance of the product, the knock-out level and the strike level will be adjusted for current market conditions and a financing rate. The financing rate is calculated and accrued daily based on the difference between two overnight floating rates minus a spread. 2. What are the risks and what could I get in return?
