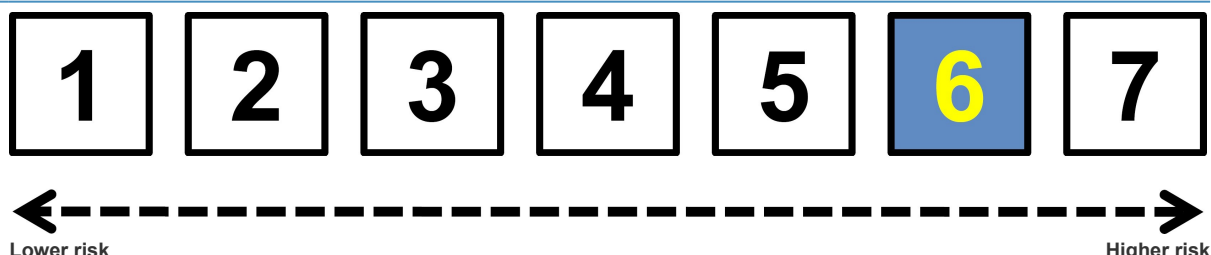
Intended retail investor
