1. What is this product?

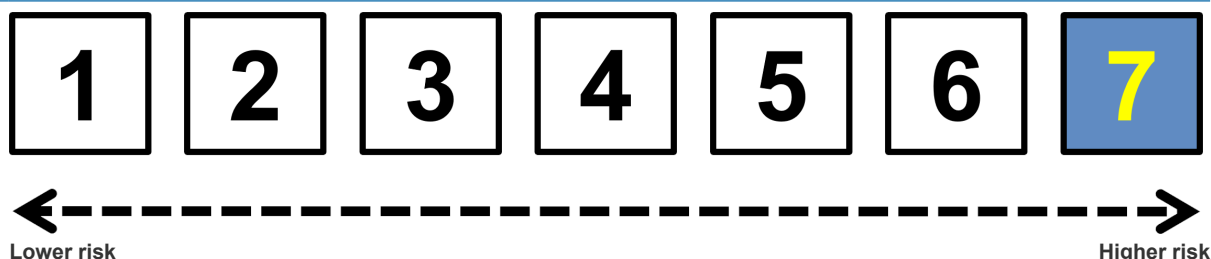

Recommended holding period: 10 months and 2 weeks
