1. What is this product?

Term	The product does not have a fixed term, subject to exercise by you or termination by the product issuer

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the underlying has risen to or above the strike price, the product will return less than your initial investment or even the minimum payment amount of EUR 0.001, which means you will effectively lose your initial investment. Leverage: The product offers leveraged exposure to the daily performance of the underlying. 5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
