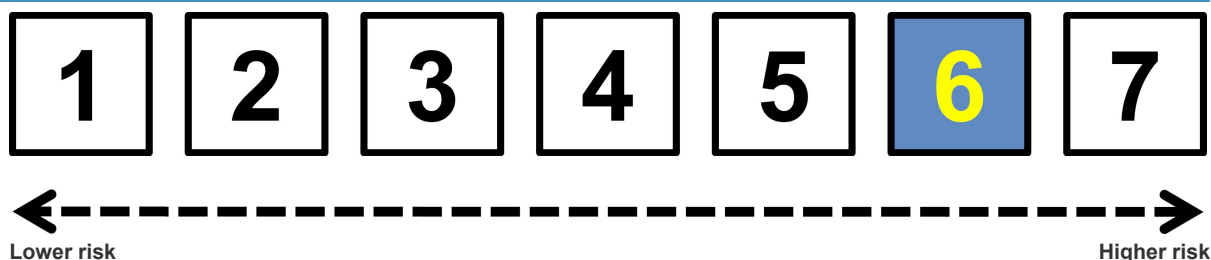

### Recommended holding period: 5 months
