The product is designed to provide a return in the form of a cash payment following exercise by you or on the **settlement date** that will depend on the performance of the **underlying**. The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the **underlying**, the product and the product issuer. 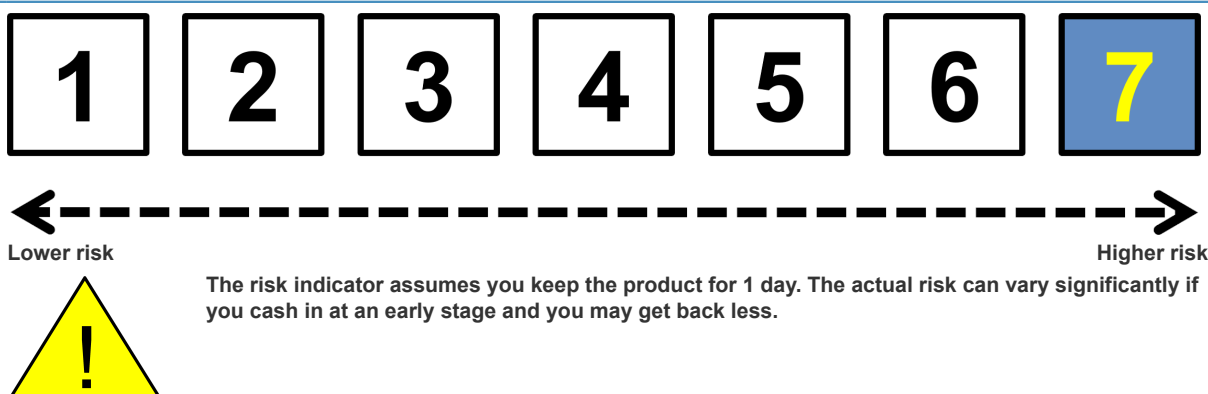
