1. What is this product?

Unless a knock-out event has occurred, you will in both cases on the settlement date receive a cash amount equal to (1) (A) the reference price on the valuation date minus (B) the strike price on such date multiplied by (2) the entitlement, and converted into EUR at the FX rate, subject to a minimum of EUR 0.001. Following the issuance of the product, the knock-out level and the strike price will be adjusted for current market conditions and a financing rate. The financing rate is calculated and accrued daily based on an overnight floating rate plus a spread. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). 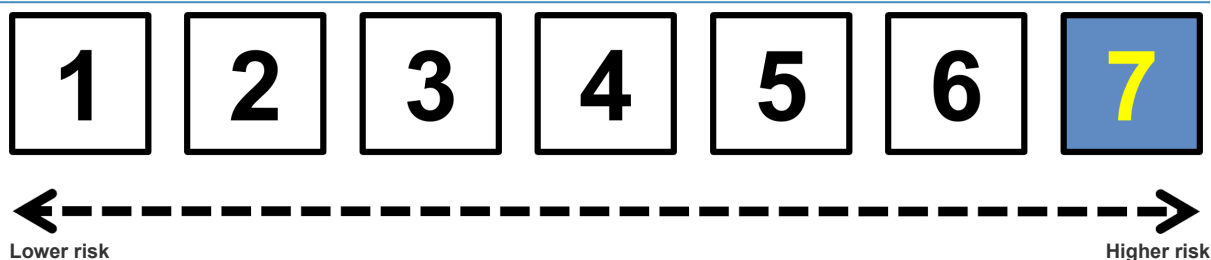

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
