1. What is this product?

The financing rate is calculated and accrued daily based on the difference between two overnight floating rates plus a spread. 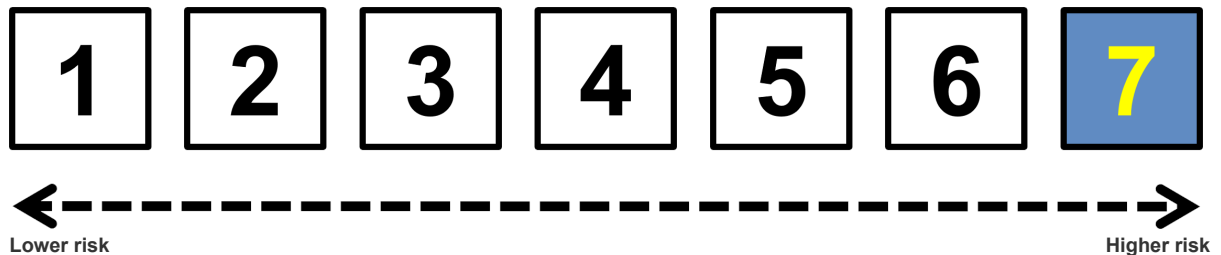

The product is intended to be offered to retail investors who fulfil all of the criteria below:

2. What are the risks and what could I get in return?
