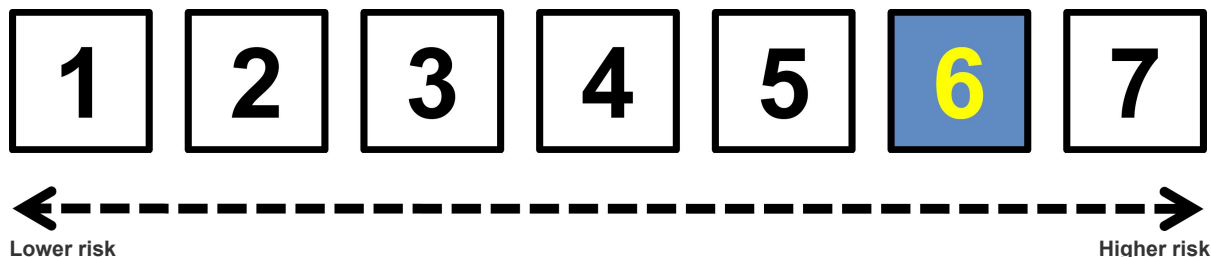
1. What is this product?

2. What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 10 months. The actual risk can vary significantly if you cash in at an early stage and you may get back less.
