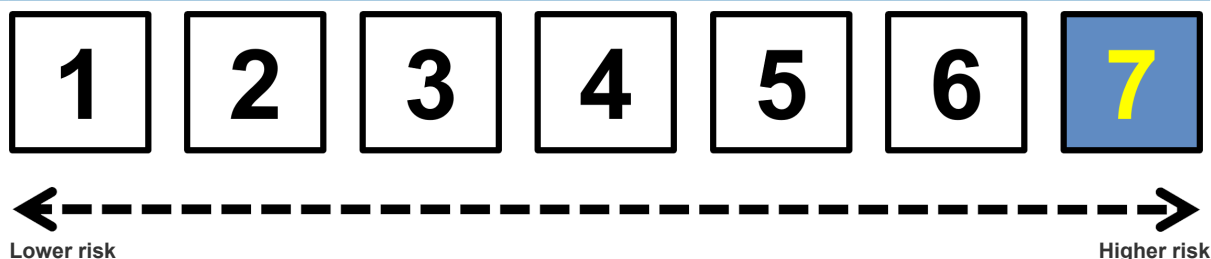

2. What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 11 months. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.
