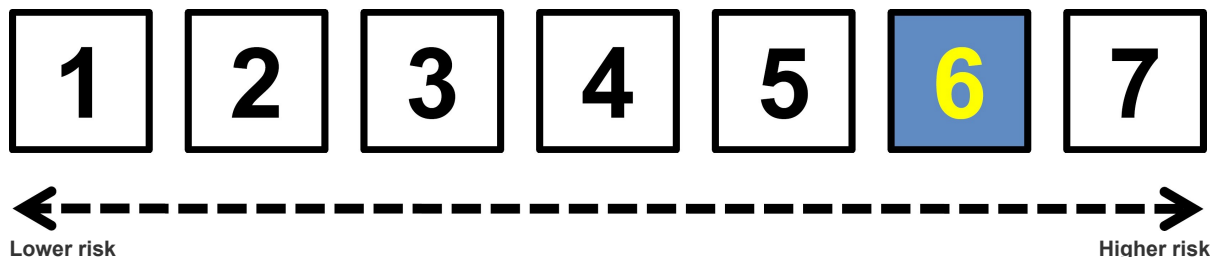
1. What is this product?

2. What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 7 months and 3 weeks. The actual risk can vary significantly if you cash in at an early stage and you may get back less.
