1. What is this product?

Any adjustments may affect the return, if any, you receive. 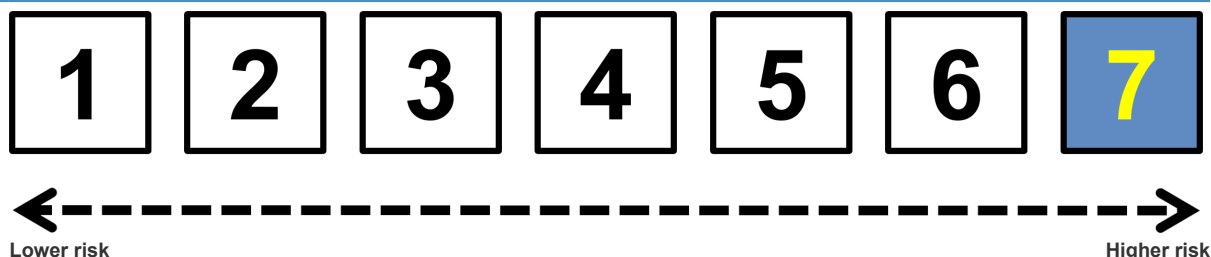

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
