1. What is this product?

The financing rate is calculated and accrued daily based on an overnight floating rate minus a spread. 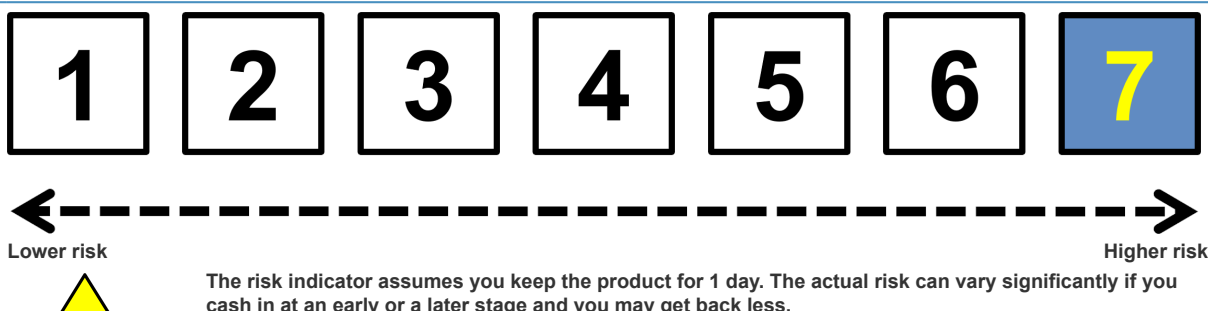
The product is intended to be offered to retail investors who fulfil all of the criteria below:
