1. What is this product?

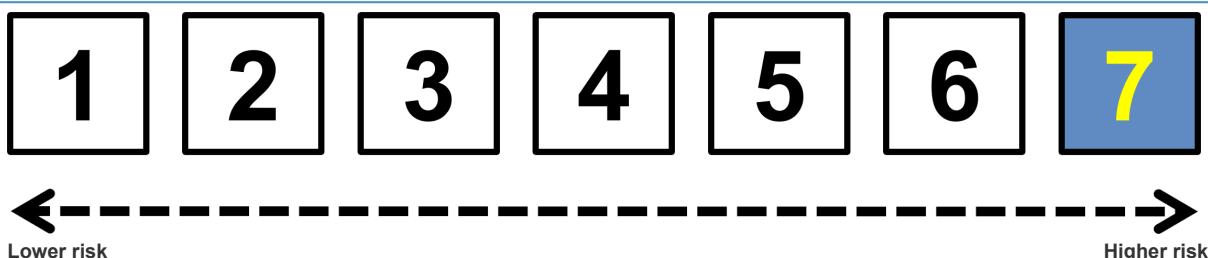
The product is intended to be offered to retail investors who fulfil all of the criteria below:
