1. What is this product?

Following the issuance of the product, the knock-out level and the strike price will be adjusted for current market conditions and a financing rate. The financing rate is calculated and accrued daily based on an overnight floating rate plus a spread. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). 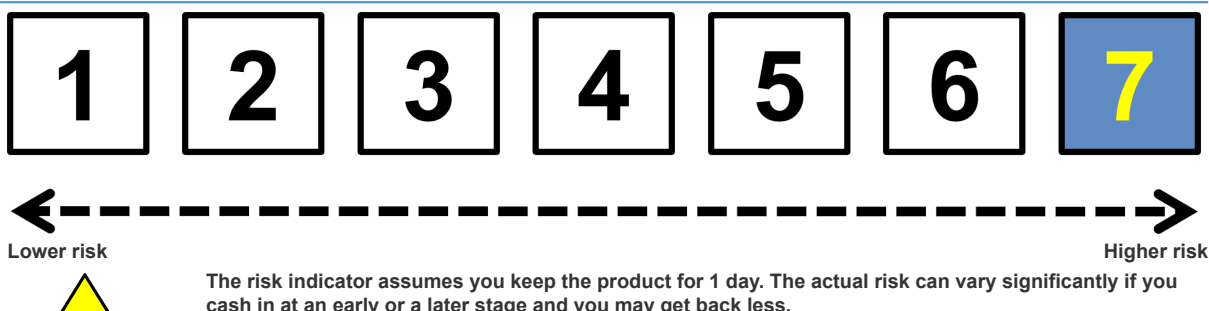
