1. What is this product?

The financing rate is calculated and accrued daily based on an overnight floating rate minus a spread. 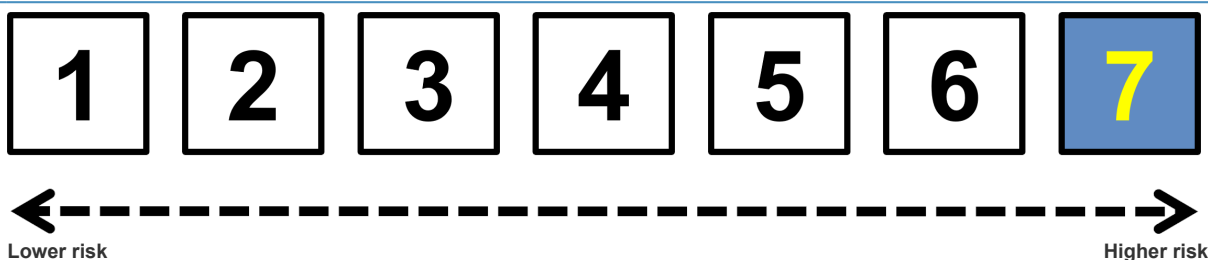
