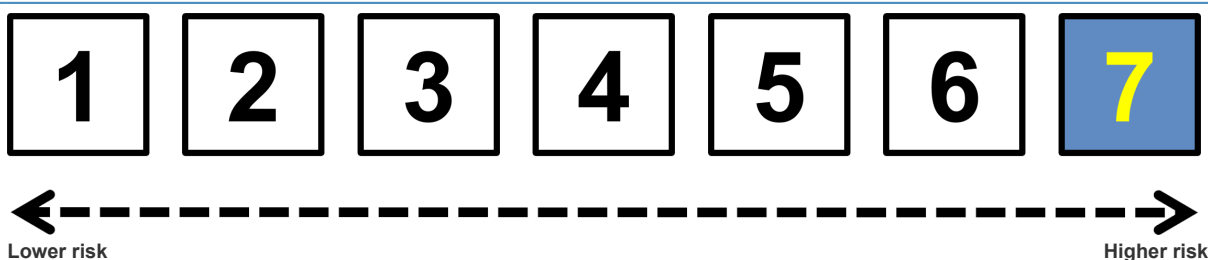
Intended retail investor

**Recommended holding period: 1 day**
