1. What is this product?

Term	The product does not have a fixed term, subject to exercise by you or termination by the product issuer

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the underlying has fallen to or below the strike price, the product will return the minimum payment of EUR 0.001, which means you will effectively lose your initial investment. Any adjustments may affect the return, if any, you receive. 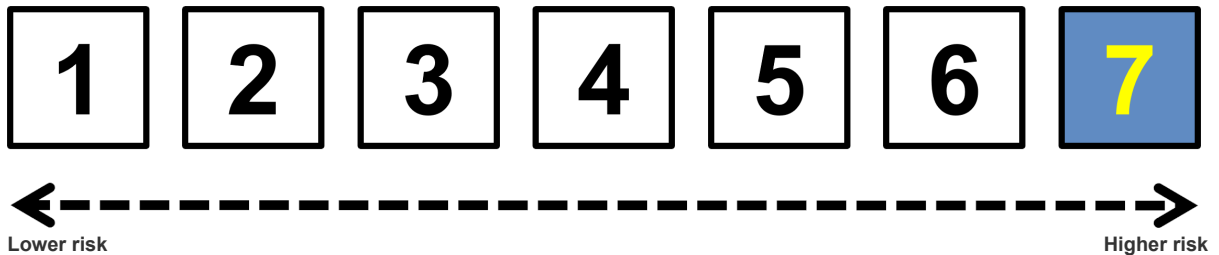

The product is intended to be offered to retail investors who fulfil all of the criteria below:

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
