1. What is this product?

Term	The product does not have a fixed term, subject to exercise by you or termination by the product issuer

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. Unless a knock-out event has occurred, you will in both cases on the settlement date receive a cash amount equal to (1) (A) the strike level on the valuation date minus (B) the reference level on such date multiplied by (2) the entitlement, and converted into EUR at the FX rate, subject to a minimum of EUR 0.001. Following the issuance of the product, the knock-out level and the strike level will be adjusted for current market conditions and a financing rate. The financing rate is calculated and accrued daily based on the difference between two overnight floating rates minus a spread. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive. 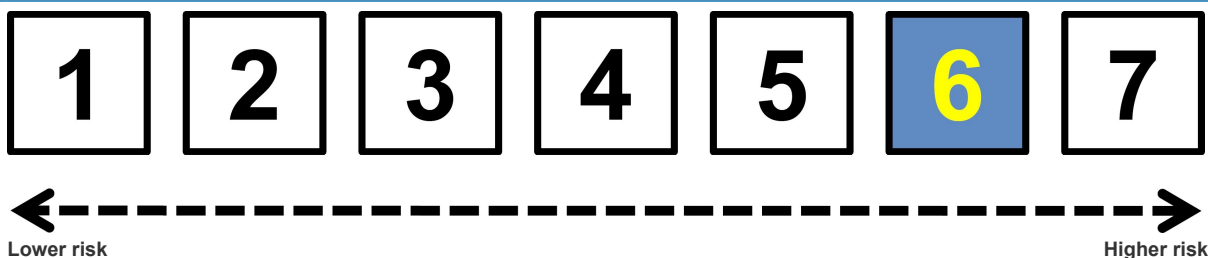

The product is intended to be offered to retail investors who fulfil all of the criteria below:

2. What are the risks and what could I get in return?
