1. What is this product?

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. Unless a knock-out event has occurred, you will in both cases on the settlement date receive a cash amount equal to (1) (A) the strike level on the valuation date minus (B) the reference level on such date multiplied by (2) the entitlement, and converted into EUR at the FX rate, subject to a minimum of EUR 0.001. Following the issuance of the product, the knock-out level and the strike level will be adjusted for current market conditions and a financing rate. The financing rate is calculated and accrued daily based on the difference between two overnight floating rates minus a spread. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). 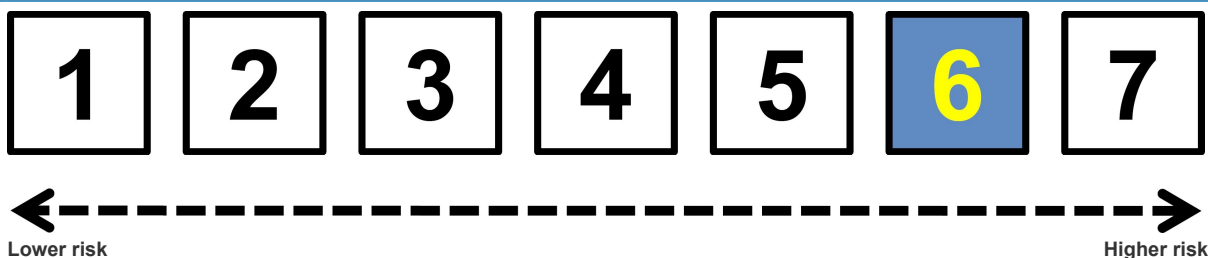

The product is intended to be offered to retail investors who fulfil all of the criteria below:

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 1 day. The actual risk can vary significantly if you cash in at an early or a later stage and you may get back less.
