1. What is this product?

Term	The product does not have a fixed term, subject to exercise by you or termination by the product issuer

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. The financing rate is calculated and accrued daily based on the difference between two overnight floating rates minus a spread. 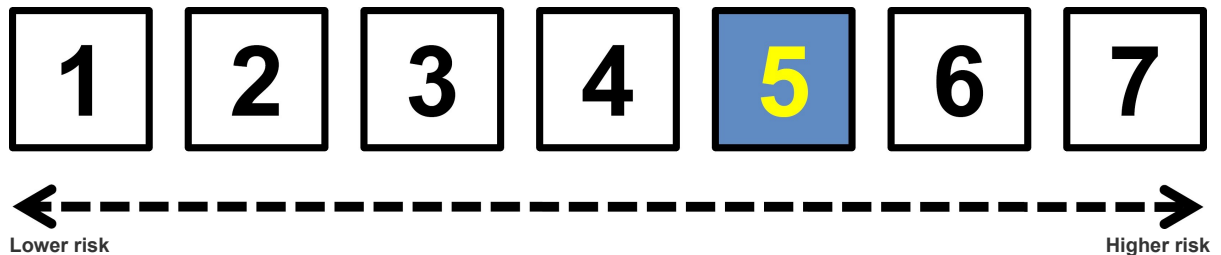

The product is intended to be offered to retail investors who fulfil all of the criteria below:

2. What are the risks and what could I get in return?
