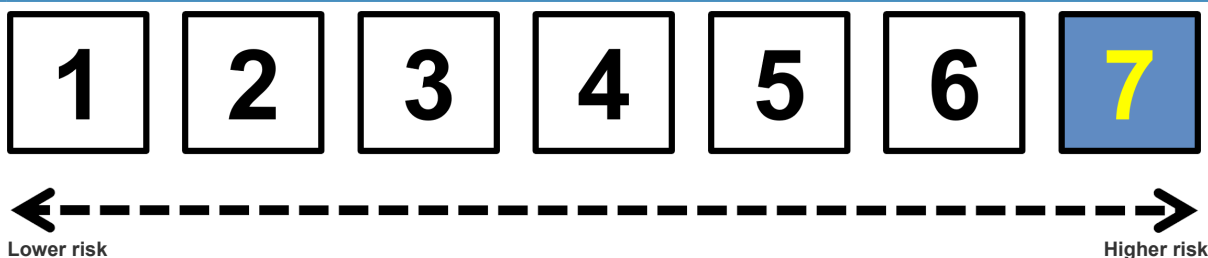
Intended retail investor

## 5. How long should I hold it and can I take money out early?

**Recommended holding period: 1 day**
