1. What is this product?

The financing rate is calculated and accrued daily based on an overnight floating rate plus a spread. 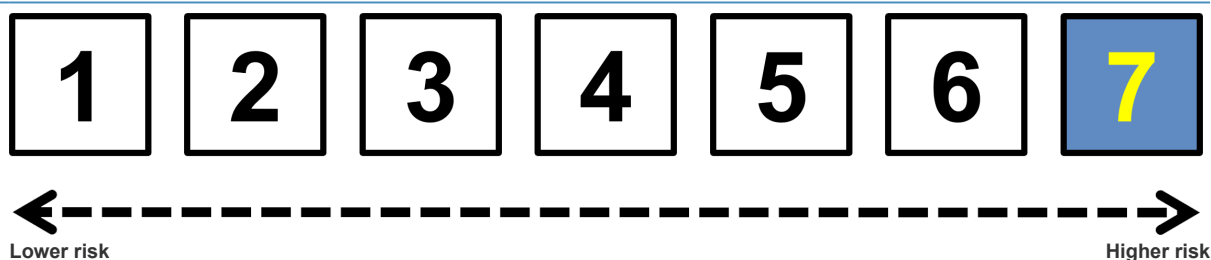

2. What are the risks and what could I get in return?
