1. What is this product?

Following the issuance of the product, the knock-out level and the strike price will be adjusted for current market conditions and a financing rate. The financing rate is calculated and accrued daily based on an overnight floating rate minus a spread. 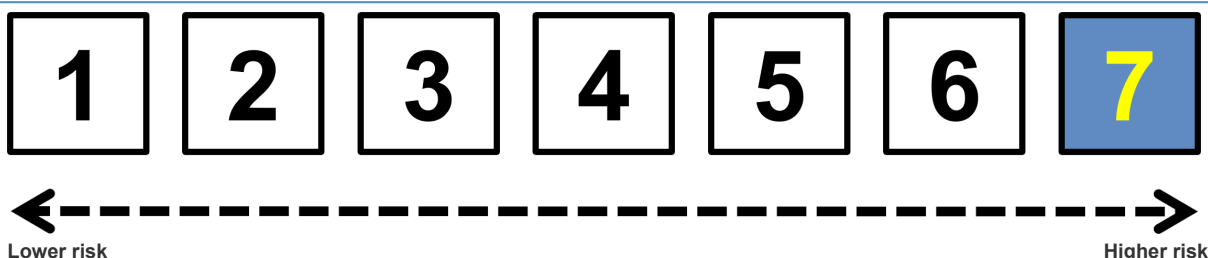
The product is intended to be offered to retail investors who fulfil all of the criteria below:
