1. What is this product?

The product is designed to provide a return in the form of a cash payment following exercise by you or on the **settlement date** that will depend on the performance of the **underlying**. Leverage: The product offers leveraged exposure to the performance of the **underlying**. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the **underlying**, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

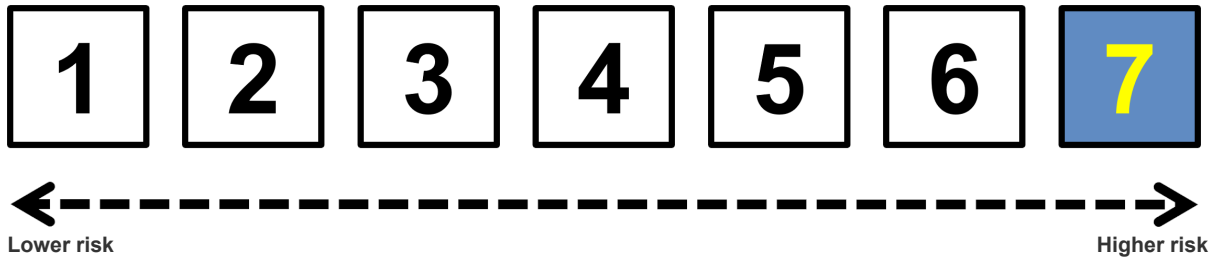
