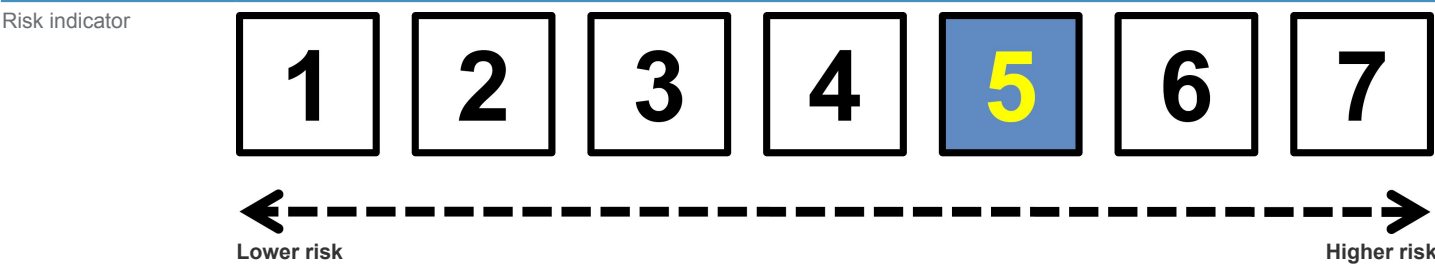

2. What are the risks and what could I get in return?

### Recommended holding period: 2 months and 1 week

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 25 September 2026 (maturity).
