1. What is this product?

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. Unless a knock-out event has occurred, you will in both cases on the settlement date receive a cash amount equal to (1) (A) the strike price on the valuation date minus (B) the reference price on such date multiplied by (2) the entitlement, and converted into EUR at the FX rate, subject to a minimum of EUR 0.001. Following the issuance of the product, the knock-out level and the strike price will be adjusted for current market conditions and a financing rate. The financing rate is calculated and accrued daily based on an overnight floating rate minus a spread. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). 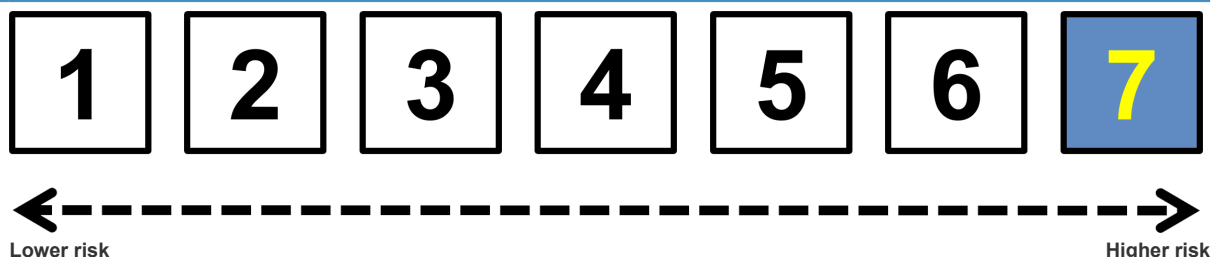
