1. What is this product?

The financing rate is calculated and accrued daily based on the difference between two overnight floating rates minus a spread. 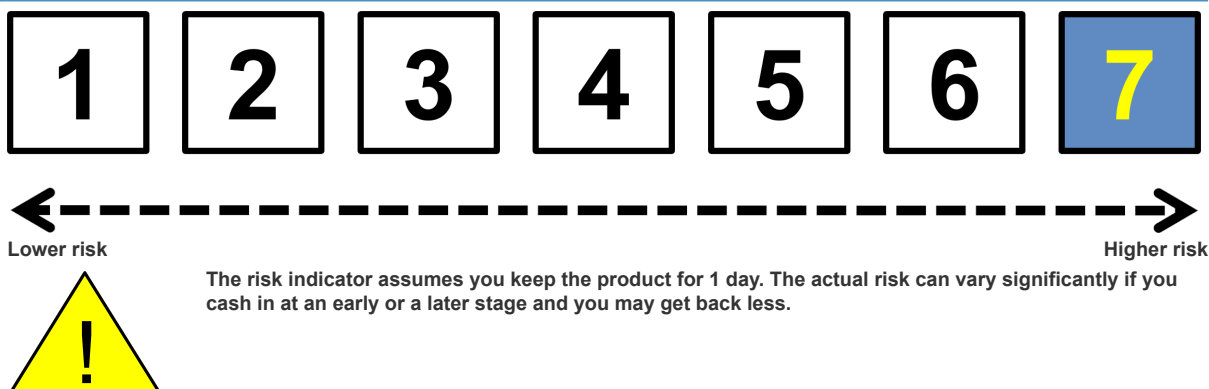
