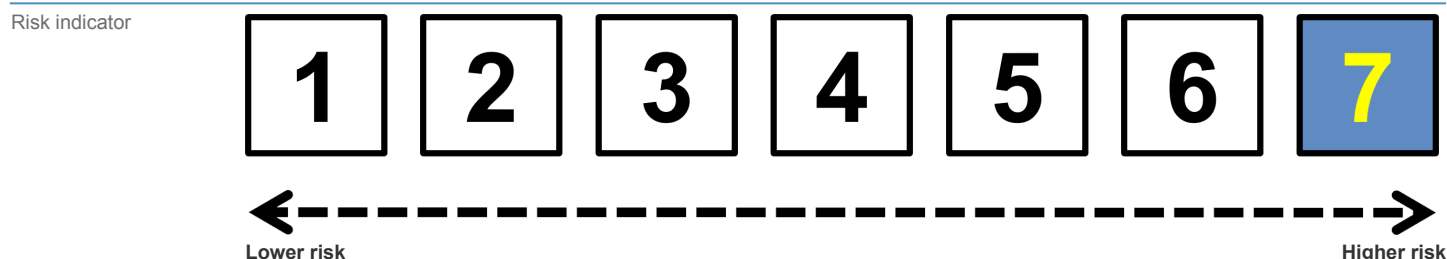
1. What is this product?

Type	German law governed warrants
Term	The product does not have a fixed term, subject to exercise by you or termination by the product issuer
Objectives (Terms that appear in bold in this section are described in more detail in the table(s) below.)	The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the underlying has fallen to or below the strike price, the product will return the minimum payment of EUR 0.001, which means you will effectively lose your initial investment. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive. 2. What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 1 day. The actual risk can vary significantly if you cash in at an early or a later stage and you may get back less.
