1. What is this product?

Following the issuance of the product, the stop loss level and the strike price will be adjusted for current market conditions and a financing rate. The financing rate is calculated and accrued daily based on an overnight floating rate plus a spread. 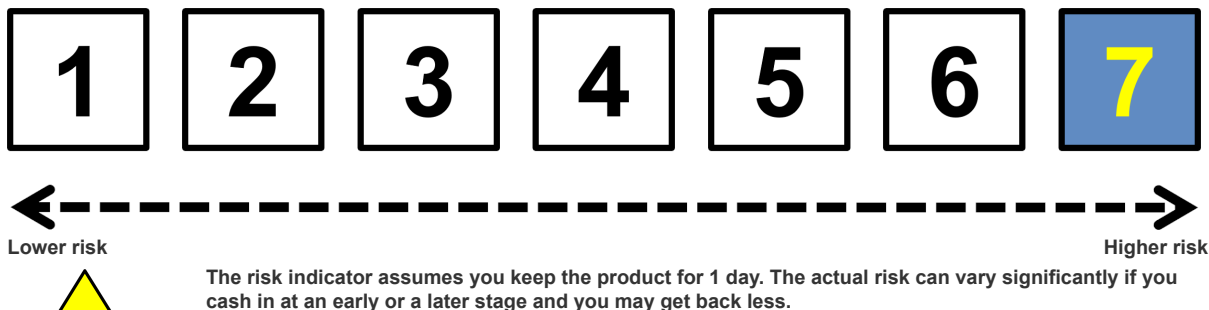

5. How long should I hold it and can I take money out early?
