1. What is this product?

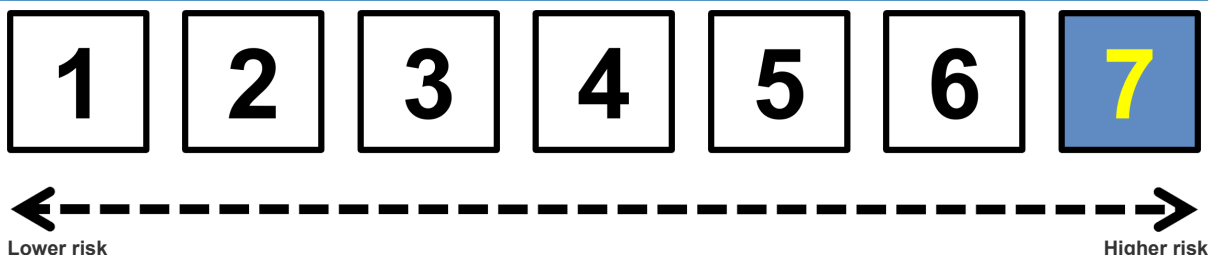

The product is intended to be offered to retail investors who fulfil all of the criteria below:

2. What are the risks and what could I get in return?
