1. What is this product?

Term	The product does not have a fixed term, subject to exercise by you or termination by the product issuer

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. The product has no fixed term. The product may terminate at any time as described below. You will in both cases on the settlement date receive a cash amount equal to (1) (A) the reference price on the valuation date minus (B) the strike price on such date multiplied by (2) the entitlement, and converted into EUR at the FX rate, subject to a minimum of EUR 0.001. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive. 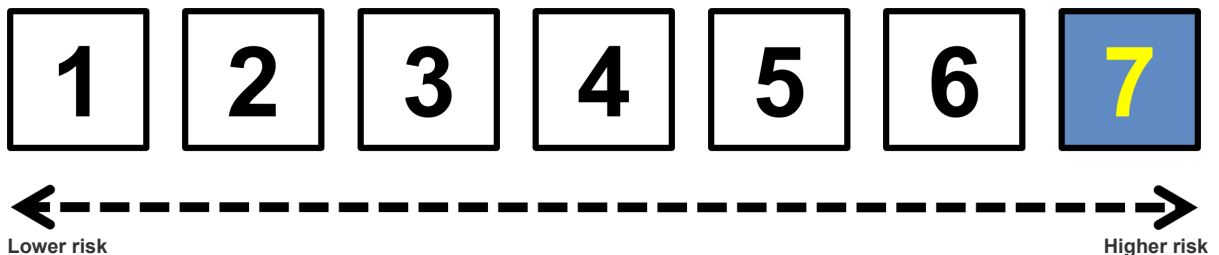

The product is intended to be offered to retail investors who fulfil all of the criteria below:

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 1 day. The actual risk can vary significantly if you cash in at an early or a later stage and you may get back less.

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day
