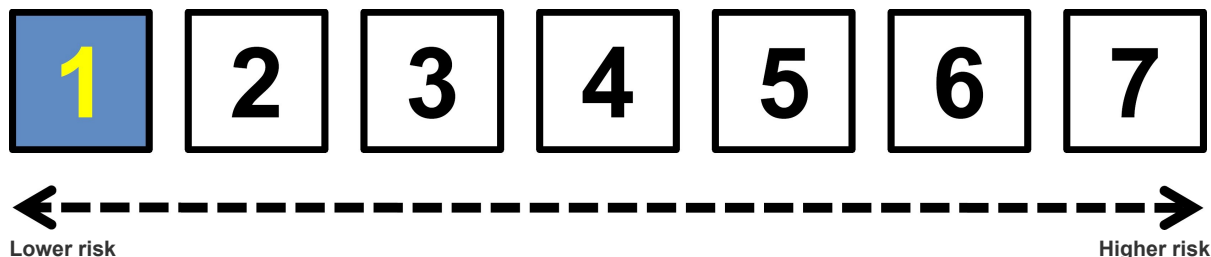
1. What is this product?

2. What are the risks and what could I get in return?

Risk indicator
