1. What is this product?

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. The financing rate is calculated and accrued daily based on an overnight floating rate plus a spread. 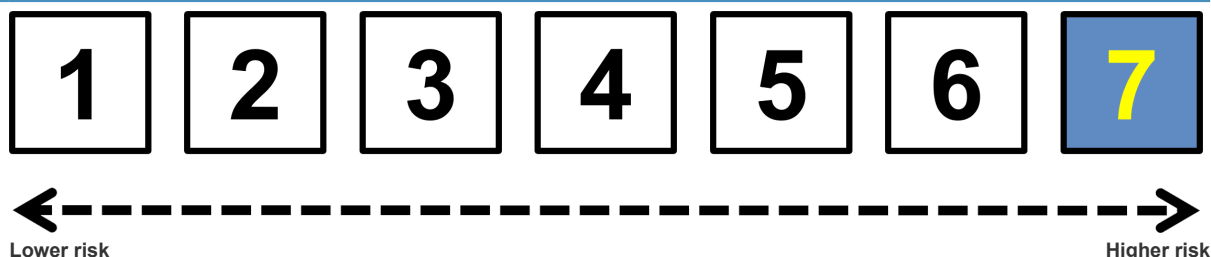
