1. What is this product?

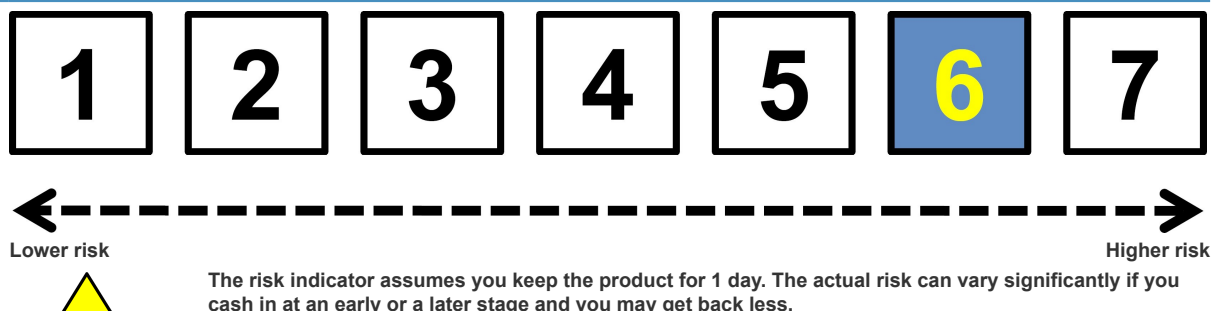
