1. What is this product?

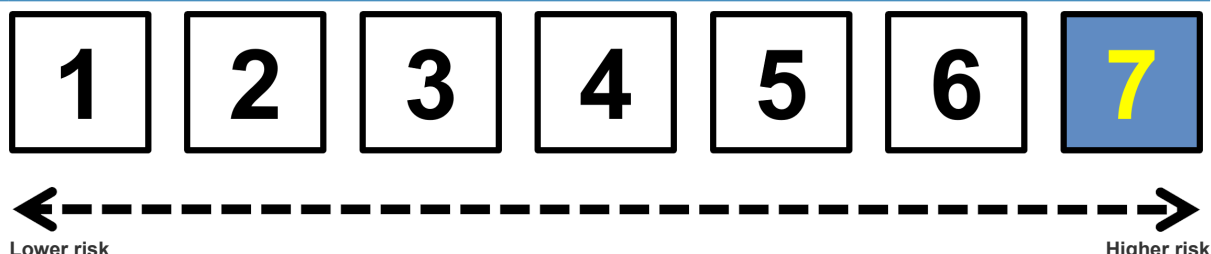

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying.
