1. What is this product?

Type

The term of the product ends on the **settlement date**

Objectives

The product is designed to provide a return in the form of a cash payment following exercise by you or on the **settlement date** that will depend on the performance of the **underlying**. If, upon exercise or termination of the product, the **reference price** of the **underlying** has risen to or above EUR 40.00, the product will return zero. Returns from an investment in the product may be achieved by means of the purchase and subsequent resale of the product, or by letting it expire.

Leverage: The product offers leveraged exposure to the performance of the **underlying**. This means that the payment you receive following exercise by you or on the **settlement date** increases on a magnified basis as the performance of the **underlying** decreases, but you also bear a greater loss if the **underlying** performs positively.

Termination on the settlement date: Following exercise of the product by you or on the **settlement date**, whichever occurs earlier you will receive:

- if the **final reference price** is below EUR 40.00, a cash payment equal to (i) the difference between (x) EUR 40.00 and (y) the **final reference price**, multiplied by (ii) the **entitlement**; or
- if the **final reference price** is at or above EUR 40.00, no payment and you will lose your investment.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the **underlying**, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.
