1. What is this product?

Term	The product does not have a fixed term, subject to exercise by you or termination by the product issuer

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the underlying has fallen to or below the strike price, the product will return the minimum payment of EUR 0.001, which means you will effectively lose your initial investment. You will in both cases on the settlement date receive a cash amount equal to (1) (A) the reference price on the valuation date minus (B) the strike price on such date multiplied by (2) the entitlement, subject to a minimum of EUR 0.001. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive. The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying, the product and the product issuer. 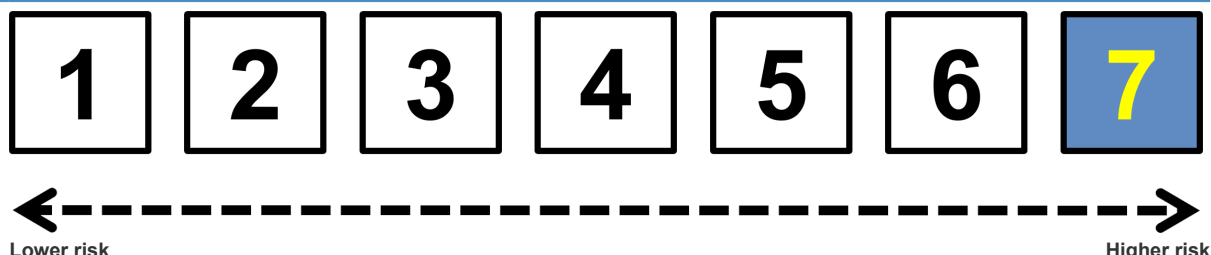

Recommended holding period: 1 day
